A \$35.00 yearly service fee will be added to membership dues. If dues have already been billed, the yearly service fee will be invoiced. The cost of the first ten (10) IDs per publication/company will be at no charge; subsequent IDs will be \$5.00 each. Per badge fees will be billed to each member's account as passes are ordered.
